DNR Report - Sarah

Rule updates

- Recycling rule: has completed the legislative review process; expected effective date is July 1.
- Hazardous waste rules: have completed the legislative review process; rules will take
 effect over the summer, with rule that adds aerosol cans as universal waste likely
 effective first.
- <u>Landfill rule</u>: no action by Senate and Assembly committees; now under review by Joint Committee on Review of Administrative Rules
- Non-landfill rule: in drafting stage; formal comment periods in 2026
- E-cycle rule: scope statement approved by Natural Resources Board last week; in drafting stage
- OFR for municipal solid waste disposal facilities permanent rule: Public hearing Feb. 6. We are tweaking a bit of minor language based on comments now. A few landfills have

been approved to use the new OFR method and a few more have either submitted requests or have indicated interest.

Upcoming public meetings:

- 5/1, 9 a.m. to noon; <u>Waste and Materials Management Study Group</u>; hope to include new compost operator member; agenda will be posted soon
- 6/6, Council on Recycling; more details coming soon

Other updates:

- No changes so far to federal grant funding, including for hazardous waste program and the EPA SWIFR grant for food waste reduction.
- We have been holding discussions with Study Group members to gather ideas for efficiencies we might be able to achieve in our work.
- We hope to post a job announcement for a solid waste engineer soon, with several locations around the state as options.
- The DNR is accepting applications for electronics collection projects that will take place between June 2025 and December 2026.

Membership / Social Media Report Ali

- Membership numbers as of last week is 129 members.
 - o Breakdown is 12 students, 11 small business, 43 private, 60 public, 1 international, and 2 retired.
 - o The 3 expiring members have been contacted.
- Issues with the SWANA membership platform will hopefully be resolved with changes to the website being rolled out.

International John Welch

- In person meeting was held last week.
 - o April

- New website certification renewal process will be much easier. Chapter events will still
 need to apply for credit beforehand, but members will no longer have to sign in to
 receive.
- A vote for the next board member to serve as the Wisconsin region representative will take place in next month.
