DNR Report - Sarah

- Rules
 - o Landfill rule: review period has ended and we're waiting for confirmation from the committee that no action is being taken; anticipated effective date is Oct. 1.
 - Recycling rule will be effective July 1; Stakeholder webinar July 15 at 10 a.m.
 Registration link
 - o Hazardous waste rules will take effect over the summer; first will be aerosol cans as universal waste.
 - Non-landfill rule drafting underway; expect some informal stakeholder input opportunities later this year.
- We still expect a Waste Management Engineer job to be posted soon
- Continuing to closely monitor federal funding; no changes so far. The most recent proposed EPA budget published late last month proposes to zero out federal funding that supports the supervision of most environmental protection programs in Wisconsin. Impacts of these proposed cuts could impact programs such as implementation of the Safe Drinking Water Act, Clean Air Act and Clean Water Act,

- among many other state and federal laws. DNR leadership and programs are closely monitoring this and planning for potential impacts.
- The Joint Finance Committee has not yet held a hearing on DNR-specific budget items, but we are expecting this soon.
