Committee Reports

DNR Report - Jennifer

- Waste Program Staffing
 - We are waiting on internal processes to post and hire Hazardous Waste
 Management Specialist, Complaints Coordinator, and E-Cycle Coordinator
 positions. Solid Waste Engineer Anne Ebent, out of the Green Bay office, left our
 program last week and we have submitted a request to hire another engineer as
 well. Keep an eye on wisc.jobs if interested in any of those.
- Federal Grants
 - SWIFR grant activities: (federal grant)
 - Contractor has conducted statewide food waste surveys and some results are coming back. Presently producing draft reports discussing results.
 - Continued focus on outreach and partnerships. Ruth O'Donnell is our Organics Waste Management Specialist (meet her at the conference!).
 - We are working on request for proposals for another contract to provide one-on-one technical assistance to businesses (or municipalities?) interested in preventing and reducing food waste.

- DOE grant on batteries- no contact from DOE since Jan. 20 (federal grant)
 - ~\$1.6M for battery education and collection

Rulemaking

- Natural Resources Board approved the landfill rule on January 22. It is still with the governor's office and is expected to be referred to the Legislature soon. *Thanks again to SWANA for your comments in support of the rule!*
- Today's NRB meeting includes a request to conduct a public hearing on the scope statement for an E-cycle rule, and a request to approve the scope statement for a non-landfill rulemaking. The NRB agenda with links to those documents is on the DNR website. The E-Cycle scope hearing, if approved, is tentatively planned for March 7 at 9:00 a.m.
- The recycling rule and hazardous waste rules are currently being reviewed by legislative committees. Jennifer met with the co-chair of the Senate Natural Resources Committee to address a few questions.
- The DNR is working with its Waste and Materials Management Study Group to assess existing procedures that impact WMM Program customers and determine potential ways to streamline and improve efficiency. The department wants to learn from partner efficiency examples and incorporate ideas into its plan review, reporting, inspection and other regulatory procedures. Advocacy Report Dave

- The owner financial responsibility bill that was changed last year has started to be used by a few government solid waste departments.
- There should be some finality of the NR-500 rules and they are already considering a plan on how the changes will be implemented.
- As wastewater treatment plants try to reduce their PFAs sources they are also going to try to manage their biosolids and how they dispose of them. If the concentrations are high, they will have to find landfills or other disposal options.
- Battery bill is on hold until June due to legislature withholding any legislation with funds attached
- A lot of opposition between the Wisconsin Manufacturer's Commerce and the Portable Battery Recycling Association.
- In the federal level, if you've applied for grant funding such as SWIFR waste reduction, education, and recycling programs may be on chopping block regardless of already existing contracts or spent funds.
